Pursuant to SEC Rules and Regulations specifically SEC Rule 606, Neonet Securities Inc. is required to disclose to its customers the policies for its orders for execution and a statistical analysis of the executions. Additionally pursuant to SEC Rule 11Ac1-3, Neonet is required to disclose its payment for order flow. Such payments typically take the form of liquidity rebates and credits. While Neonet may consider payment for order flow in making routing decisions involving customer orders in Covered Securities, we are committed to providing our customers with best execution.
